AEROSPACE/ROCKETRY – Exhibitor may enter up to two rocket exhibits. An exhibitor may not enter two rockets in the same class.

AG MECHANICS WELDING – Exhibitor may enter up to two exhibits in different classes.

AGRONOMY – Exhibitors are limited to one entry per class.

ASTRONOMY – Exhibitors are limited to one entry per class.

BUILDING BLOCK ENGINEERING – Exhibitors are limited to one building block engineering exhibit.

COMPUTER SCIENCE – Exhibitors are limited to one entry per class.

ELECTRIC AND RENEWABLE ENERGY – Each exhibitor may enter up to two electric and renewable energy exhibits. An exhibitor may not enter two electric and renewable energy exhibits in the same class.

ENTOMOLOGY – Each exhibitor may enter up to two entomology exhibits. An exhibitor may not enter two entomology exhibits in the same class.

FIBER ARTS – Exhibitors are limited to one entry per class.

FOOD AND NUTRITION – PREPERATION – Each exhibitor may exhibit up to four entries in Non-Perishable Food Product, and one entry in each of the other classes in this division.

FOOD AND NUTRITION – PRESERVATION – Exhibitors are limited to one entry per class.

FORESTRY – Each exhibitor may enter up to two exhibits in Forestry but only one entry per class. Participants can exhibit in a collection phase and one other class or they may exhibit in any tow non-collection classes.

GEOLOGY AND LAPIDARY – Exhibitors are limited to one entry per class.

HORTICULTURE AND LANDSCAPE DESIGN – Exhibitors are limited to: One Garden Display; Up to four produce exhibits; Up to four floral exhibits; One Notebook exhibit.

INTERIOR DESIGN AND ARCHITECTURE – Exhibitors are limited to one entry per class.

MISCELLANEOUS – Exhibitors are limited to one entry per class.

PHOTOGRAPHY – Each exhibitor is limited to four photographs and other classes based on years of experience.

ROBOTICS – Exhibitors are limited to one entry per class.

SEWING AND TEXTILE DESIGN – Each exhibitor may enter a maximum of two exhibits in this division.

SEWING AND TEXTILE DESIGN REVUE – Exhibitor may model up to two outfits with one being selected for public style revue.

SHOOTING SPORTS – Exhibitors are limited to one entry per class.

SHOPPING IN STYLE – Exhibitor is limited to one shopping in style exhibit.

SHOPPING IN STYLE REVUE Exhibitor may model up to three outfits with one being selected for public style revue.

SMALL ENGINES – Exhibitors are limited to one entry per class.

UNCREWED AIRCRAFT SYSTEMS – Exhibitors are limited to one entry per class.

VETERINARY SCIENCE – Exhibitors are limited to one entry per class.

VISUAL ARTS – Exhibitors may enter up to 5 exhibits, with no more than 2 per class.

WILDLIFE – Exhibitor may make only one entry in display/posters/notebooks and one entry in experiential within this division.

WOODWORKING – Exhibitors are limited to one entry per class.
